1. About these terms and conditions

1.1. These Specific Product Terms

- a. This document is known as 'Specific Product Terms' [SPT], and states the specific terms and conditions under which VISITS agrees to supply the following Products and/or Services to the Customer, and upon which the Customer agrees to procure those Products and/or Services from VISITS
- b. The Products and/or Services too which these Specific Product Terms apply include:
 - i. Products and Services advertised or shown on the VISITS Store.
 - ii. Quotations sent to the Client via the VISITS Store, including Products and Services contained within those Quotations.
- c. These Specific Product Terms form part of the Agreement with the Customer, and should be read in conjunction with the other documents which form part of the Agreement including the MSGA and Dictionary available from our website at https://visits.com.au/documents as well as any Statement of Work.

2. Pricing & Payments

2.1. Pricing

- a. Unless specifically stated otherwise, all prices on the Store are quoted excluding Goods and Services Tax (GST). GST will be added to each Tax Invoice.
- b. Prices promoted on the Store are at RRP or SRP until you log in to obtain the discounted pricing as arranged with VISITS. Discounts will be automatically applied for online orders. Percentage discounts promoted on a Product listing are with respect to RRP or SRP. Note some special bid items and some licensing may not be available for online ordering. Please contact your account manager or call 1300 300 979 to order items unavailable online.

2.2. Payments

- a. Where the Customer does not have a Credit Account with VISITS, payment terms for all Products and Services quoted or sold via the Store are CBD (cleared funds before delivery).
- b. Where the Customer has a Credit Account, payments will be in accordance with the terms and conditions contained in the MSGA.

3. **Errors and Omissions**

3.1. Products

Legislated Rights 4.
